Your Chairman's Concerns

Creep Hurdles

Some of you will be pleased to see that my offering this time involves no welding! I have decided however to revert to imperial measurements because that is what I happened to use at the time and conversion to metric would give some silly figures. Soon after I started to keep sheep I decided I needed a creep hurdle. However I had no idea what gap to provide that would allow the lambs through but to keep the ewes out so I decided to make three alternative gap sizes. These would be 6 ¾", 7 ½" and 8"and I thought that two of each size would give me one hurdle to allow the lambs to get to creep feed in a pen and a second hurdle to allow lambs through a gateway to fresh grass. Consequently I made three hurdles each capable of adjustment to two sizes.

The hurdles are constructed in wood and held together with M5 bolts 140mm long with wing nuts. (No I have not used imperial bolts!) From the drawing attached one can see that the vertical bars are of 2" square section 36" long except at one end where it is 72" long. The horizontal members are of 3 by 2" section and are also 72" long and the diagonal brace is of 2 5/8" by ¾" section and is also 72" long. Over the parts of each bar which the lambs rub against, I rounded all four corners. The assembly was originally creosoted and over the years the bars have become polished by use. All the holes are drilled 6 mm diameter to provide a working clearance and are in the centre of the 2" width of the vertical and horizontal members.

All the bars are identical so having drilled one it was used as a template to drill all the others. By using a pillar drill it was possible to ensure all the holes were at right angles to the bar. The interesting part comes when we have to drill all the holes for the two alternative gap sizes. The holes in the horizontal members were made again using the pillar drill and the hole positions were according to the table below.

Hurdle number 1 is for 7 $\frac{1}{2}$ " and 8" gaps so dimension "A" is 9 $\frac{1}{2}$ " and "B" is 10". Hurdle number 2 is for 6 $\frac{3}{4}$ " and 7 $\frac{1}{2}$ " gaps so dimension "A" is 8 $\frac{3}{4}$ " and "B" is 9 $\frac{1}{2}$ ". Hurdle number 3 is for 6 $\frac{3}{4}$ " and 8" gaps so dimension "A" is 8 $\frac{3}{4}$ " and "B" is 10".


In addition to the 72" vertical bar all hurdles need 8 of the 36" bars. However when assembled for 8" gaps, hurdles 1 & 3 each have a surplus bar. When hurdles 1 & 2 are assembled for 7 $\frac{1}{2}$ " gaps there has to be an unusable gap as shown to the left side of the drawing.

Drilling the diagonal brace requires one or two holes in odd places and I have not bothered to dimension these. The three requirements for positioning the diagonal are 1) that it holds the vertical bars at right angles to the horizontal bars, 2) that it should not prevent access to the wing nuts securing the vertical bars and 3) they should not impede too far into any gap. The fact that the diagonal brace does not lie flat has not been a problem.

In order to keep the hurdles in sets I have put a blob of paint on each component using Black, White and Red paint to distinguish between the three hurdles.

My experiment with gap sizes has been interesting. I have the Derbyshire Gritstone breed of sheep and I have found the $7 \frac{1}{2}$ " gap the most successful. The lambs quickly out grow the $6 \frac{3}{4}$ " gap and some of the adult ewes, especially just after shearing, can get through the 8" gap.

Docks

I have a continuing problem with docks in one of my fields. I have a competition with one of my neighbours (organic) to see which of us can grow the largest docks and he always wins as he manures his. Yes I know I should cross graze but that is a difficult option so I prefer to follow an even more difficult path.

I have tried topping on a regular basis but have found that the wily pests then grow horizontally just below the height of the topper and then go to seed very quickly.

I have also tried spot spraying with chemicals Grazon 90 and Glyphosate. Glyphosate works well but does kill all the grass around the dock. Grazon 90 instructions say that established docks will need to be treated over two years but I have found this is not very effective. A routine which appears to work is: Spot spray with Grazon 90 and a few days later go around spraying any that are not wilting as these are the ones I have missed. Then a couple of weeks later spot spray again this time doing the little pests that are showing signs of recovering. On a few really persistent ones spot spraying again a few weeks later will get them. I would like to be able to say that I no longer have any docks but they keep on coming back, probably from seed, although they are getting fewer. Any alternatives always considered, apart from cross grazing, let me know.

Swine Flu in Pigs

DEFRA have issued a Code of Practice document for pig keepers on how to minimise the risk of introducing H1N1/09v (Swine Flu) to pig herds and how to minimise the spread should your herd be affected. See:

SPS Payment - Minimum Size Set

DEFRA have announced the result of the consultation mentioned in the last issue of Gate. The minimum size for claiming under the Single Payment Scheme has been set at one hectare. This is the minimum allowed under EU rules. The objective farmer test will not be implemented. This is subject to detailed EU scheme regulations and any further clarifications from the EU commissioners.

It is claimed that each payment under SPS costs £2,000 to administer. As the payment for each hectare is approx £96 this means that the cost of administering a payment for less than 20 hectare (500 acres) is more than the payment.

Recently a root and branch review of the Rural Payment Agency has been announced. Katrina Williams, director general of DEFRA's Food and Farming Group, will chair the review


Avis goes to the Palace
